Rehearing the appeal of the Department of Civil Rights' finding that Payne & Dolan, Inc's SBE Bid for Contract 8703, Resurfacing 2023 – Asphalt Pavement Pulverizing, Milling & Paving was non-responsible due to failure to meet the prescribed goal for this project, and not demonstrating sufficient good faith effort to meet the prescribed goal for the project.

2. CONSIDER THE FOLLOWING QUASI-JUDICIAL HEARING ITEM

Appeal of the Department of Civil Rights' finding that Fahrner Asphalt Sealers, LLC's SBE Bid for Contract 8699, Pavement Crack Repair and Chip Seal 2023, was non-responsible due to failure to meet the prescribed goal for this project, not demonstrating sufficient good faith effort to meet the prescribed goal, and failing to submit completed SBE Contact Reports.

Stats. 19.85(1)(a) to deliberate concerning the case that is the subject of the quasi-judicial hearing before The Committee. The Committee may reconvene in open session immediately following any such closed session.”
