# **Quick Guide to Checking ID**

Review this before checking voter IDs.

We check ID at the poll book, per the WI Elections Commission.

# 1. Be respectful. Offer to check voter's ID while the other official finds their name on the poll book.

- ✓ Never comment about how good or bad someone looks in their photograph.
- ✓ Never comment about changes in weight, hairline, etc.
- ✓ IDs contain confidential information. Only poll workers may examine a voter's ID.
- ✓ Do not handle the voter's wallet.
- ✓ Confidential voters are exempt from showing ID. Instead, they show you a
  confidential voter card issued by the City Clerk's Office.

#### 2. Make sure type of ID is acceptable – one of the following:

- √ Wisconsin driver license expiring after 11/5/2024
  - No hole punched through expiration date
- √ Wisconsin ID card expiring after 11/5/2024, or non-expiring
- √ U.S. passport (book or card) expiring after 11/5/2024
- √ Military ID card expiring after 11/5/2024, or non-expiring
- ✓ Certificate of naturalization issued within the last two years
- ✓ Unexpired Wisconsin driver license or state ID receipt
- √ ID card issued by a federally recognized Indian tribe, regardless of expiration
- √ Student ID issued by a Wisconsin accredited college or university
  - If expired, accompanied by proof of current enrollment
  - Has student's signature
  - Lists issuance date
  - Expires within 2 years of issuance
    - UW-Madison Voter Identification Card is acceptable, but WisCard is not.
- ✓ Unexpired or non-expiring ID issued by Veterans Affairs
- ✓ Citation or notice of intent to revoke or suspend a driver license, dated within 60 days of the election (see Election Official Guide for process)

## 3. Make sure expiration date on ID is acceptable.

- ✓ Expires after 11/5/2024 for Wisconsin driver license, Wisconsin ID, U.S. passport, or military ID
- ✓ A non-expiring Wisconsin ID or military ID is not expired, and is acceptable
- ✓ Unexpired for Wisconsin driver license receipt or Wisconsin ID card receipt

- ✓ Certificate of naturalization issued within last 2 years
- √ Expired ID card issued by a federally recognized Indian tribe is okay
- √ If an acceptable college ID is expired, must show proof currently enrolled

#### 4. Make sure name reasonably conforms to poll book.

- ✓ The official looking up the name on the poll book is comparing the name stated
  to the name on the poll book. They will notify you if the name on the poll book
  differs from the name stated.
- ✓ Use common sense. An exact name match is not required. Bob conforms to Robert. Peggy conforms to Margaret. Witzel-Behl conforms to Witzel or Behl.

#### 5. Make sure photo reasonably resembles voter.

- √ Use common sense. Photo may be a decade old.
- √ Show dignity and respect.
- ✓ If in doubt, contact Chief Inspector.
- ✓ Note that two acceptable types of ID will not contain a photograph:
  - 1. A citation or notice of intent to revoke or suspend a driver license, dated within 60 days of the election.
  - 2. Wisconsin ID without a photo, issued to someone with a religious objection to being photographed

#### 6. If WI ID/DL says Limited Term or Non-Domiciled

- ✓ Poll worker asks, "The DMV has indicated that your ID is issued to lawful temporary visitors to the United States who are not United States citizens. Do you have with you your naturalization certificate, U.S. passport, or other document that shows you are a United States citizen?"
- ✓ If voter does not have proof with them, contact Chief Inspector to begin Challenge Process.

### Not accepted as voter ID:

- Out-of-state driver license or ID
- State or Federal government employee ID
- Transportation Worker Identification Credential (TWIC)
- Homeland Security Trusted Traveler card

- Membership or organization ID
- Certificate of citizenship
