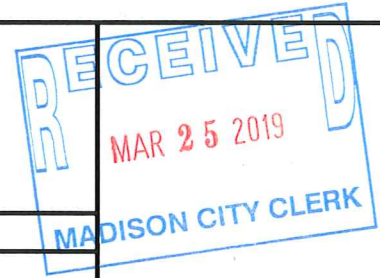

- Candidates may not terminate prior to the election in which they are participating.


