Project Details – Proposed Work

Sanitary Sewer: The project will remove and replace the sanitary sewer main, which is located in the parking lot area of the Fordem Towers apartments. Sanitary sewer laterals will be reconnected to the sewer main after the sewer main is installed. After replacement of the sewer main and reconnection of laterals, an asphalt pavement patch will restore the road surface to a drivable condition.

Water Main: No water main work is anticipated with this project.

Storm Sewer: No storm sewer work is anticipated with this project. (Storm sewer owned and maintained by Monarch Investments)

Street: After the sanitary sewer main and reconnection of laterals has been completed, the pavement will be patched with asphalt material over the entire width of the trench. Pavement Markings of parking stalls that are disturbed will be replaced.

Trees: No trees are planned to be removed with this project. The Contractor may need to prune branches of trees that overhang into the project area in order to ensure no damage is done to the tree by equipment accidentally damaging the limps.

Street Lights: There is not any street light work planned as part of this project.

Construction Schedule & Impacts

Schedule: Work is planned to begin the week of August 15th, 2022, and is anticipated to last until September 6th, 2022 but work is anticipated to be completed earlier than this date.

Traffic & Access Impacts: Streets and parking lot areas near the project limits will remain open for traffic. Due to the location of the sanitary sewer main being replaced, there are a number of parking spots that will need to be closed during construction. No Parking signs will be placed in parking stalls and those signs will indicate the dates that no parking is allowed. The Contractor is only allowed to close 15 parking spots at any given time. There will be temporary parking areas designated with signage near the project area for residents impacted by the construction to park temporarily while construction is under way.

Handicap parking stalls will be provided at all times during construction. Temporary handicap stalls will be designated when construction requires the current handicap stalls to be closed.

Water Shut-offs: No water shut-offs are planned with this project.

Refuse Collection: Refuse collection will continue as usual.
