<u>Dan Williams/MSA</u> -Phases/full project re-cap; "culmination from lots of input from public" (>3 minutes); then runthrough on proposed design

- Annie Steward Fountain (based on 20xx study is in need of reconstruction/restoration. Much of the existing fountain is beyond repair. Master Plan proposes to relocate a reconstructed fountain at the new pedestrian entrance at Drake and Randall. Master plan to acknowledge that Landmarks will need to be involved if there is interest in relocating fountain AND emphasize that proposed DRAFT Final MP shows fountain in its existing location and proposes a relocation]
-Vilas Park Drive is proposed to be closed to through traffic from the Historic bridge at Edgewood Avenue to the access for the proposed park shelter. When asked a majority of public comments supported the closure of Vilas park Drive and replacement with a multi-use path. CoM Planning staff has recommended a RESJI analysis of this proposal to assess level of accessibility lost.

<u>Kate Kane/Parks</u>: Board of Park Commissioners will review and adopt (if chosen) the Master Plan. Initial presentation will occur at January or February 2021 meeting. The project will be a phased development of the master plan elements with individual further design development, site plan review, and public comment prior to any implementation. The goal of the master plan is to help Parks Division identify and schedule capital projects within Vilas Park.


Chris Wells/Planning – not sure if PC is required(?), staff will discuss and follow up with Parks staff

Bill Sullivan/Fire – make sure that turn-around available in N lot; full fire truck turning radius needed; hydrants for S shelter

<u>Tim / Metro</u> – do not want to be in parking aisle for bus drop-off (concern is that cars would be backing into bus travel lane – cars at N/W area of lot); typical for transit service is to have scheduled stop if shuttle service & might hang-out / wait a while (another reason bus drop-off might not work well as shown);


