Parking tickets are the responsibility of the registered owner of a vehicle. If you received notice of a parking ticket after selling a vehicle, this indicates that the buyer had not yet registered the vehicle at the time it was ticketed. As the last registered owner, you must take action to resolve the parking ticket. Note that failure to take action on the ticket may result in additional fees or license plate suspension. The following options are available to you:

Submit the Sold Vehicle Form to request a Parking Ticket Transfer

Complete the Sold Vehicle Form on the reverse side of this letter. To qualify as acceptable proof of sale, all fields must be completed, and the form must be notarized. Submit the form to the Court Services Unit. If you are unable to provide all required information, you cannot use this option to resolve the ticket.

OR

Contest the Ticket in Parking Court

Call Court Services at 608-266-4170 to request a parking court date to contest the ticket.
