






How well are the police doing at the following?



According to the respondents, the police are doing **a good job** in all given areas, but 24% of respondents feel that the police are doing a **poor/very poor job** of being visible on the streets.



How common is it for the police to do the following?




According to the respondents, it is **common** for the police to act professionally. The majority of the respondents indicate that it is **uncommon** for police to stop people without good reason, use excessive force or offensive language, break the law or police rules, or treat people differently based on race, ethnicity, gender identification, religion or immigration status.

How worried are you about the following?



The majority of respondents are **at least somewhat worried** about all of the given issues, and are very worried about people using or selling guns.

Please indicate how much you agree or disagree with the following:




The majority of respondents **agree** that they trust their police department, have confidence in them, would feel comfortable calling them if needed, believe that the agency would take complaints against officers seriously, and have confidence in the department's ability to investigate and solve major cases and use public funding and resources wisely.

How likely would you be to do the following?



The majority of community members would be **likely** to work with the police to identify a person who has committed a crime, or places where crimes have taken place, as well as attend a meeting of residents in their neighborhood to discuss crime prevention.

A majority of respondents **agree** that they feel an obligation to obey the law and that, when a police officer makes a request, they should comply even if they disagree with it. 47% **agree** that they sometimes question the laws they are asked to obey.

Is there anything you would like to share about your local agency and/or its officers, good or bad?


Themes

Three overarching themes surfaced through the open-ended question that provide insight into the respondent's perspectives of the police department and its operations: positive affirmation, the need for more enforcement and visibility, and the need for more officers². 240 (32%) of the open-ended responses are positive, affirming that the Madison PD is doing a good job; 136 (18%) of the open-ended comments indicate that the respondents think that the department needs to increase visibility, enforce more laws (respondents commonly cite traffic-related enforcement) and engage more proactively in communities; and 131 (17%) of respondents indicated that the department needs additional officers in order to be more effective. In addition to these themes, 127 responses (17%) indicated that participants were not pleased with the level of support the City and DA provide to the department.


² 607 participants provided open-ended responses, however some comments were robust and two main themes emerged. These comments were split into two to ensure both themes were included in the results. The statistics above are based on the resulting 760 comments.


What neighborhood do you reside in?








