## **Tablets2Go Program Helps Digitally Connect Seniors During Isolated Times**

In August the Madison Senior Center kicked off its new Tablets2Go program. Tablet computers can be a great way to check email, communicate with loved ones, and connect with virtual programs online. Unfortunately many folks don't have access to quality computers or tablets. The Tablets2Go program lends tablets to those that cannot afford or don't own a computer. Tablets are available to adults age 55+ who are registered for a Madison Senior Center program.

Donations to Madison Senior Center Foundation helped pay for 12 tablets this summer. Participants have begun renting out tablets for use with our virtual programming. Financial support keeps people connected during these isolated times.

# Oak Park Place Senior Open raises almost \$11,000 for the Madison Senior Center

On September 15, 40 golfers, practicing healthy safety measures, took part in the first ever Oak Park Place Senior Open to raise \$10,985 for the Madison Senior Center Foundation. Oak Park Place with additional support from The Golf Affect (a local radio show) sponsored and held the event in support of the Senior Center's efforts to purchase upgrades to the AV equipment in classrooms.

The Madison Senior Center will use proceeds from this fundraiser towards the purchase of audiovisual equipment. Many individuals who utilize our space and participate in programs, activities and classes experience hearing and vision loss. Therefore, it is critical that we have the equipment to make these programs accessible to all. There are plans to purchase large video monitors. new projectors, projection screens, headsets with microphones for facilitators and presenters, well as standalone microphones. All of these AV upgrades will provide increased opportunities for seniors of all abilities to hear and see presentations and to fully participate in programming at the Senior Center.

#### **Intergenerational Volunteering During Pandemic**

It's often difficult to create and maintain friendships, and it is now even harder due to COVID-19. No one faces this challenge more than older adults. As the pandemic drags on the Senior Center is stepping up to provide opportunities for meaningful interaction. The following are just a few ways that folks of differing ages are connecting to increase socialization, learn from each other, and combat isolation.

#### **PEN PAL PROGRAM**

The Pen Pal Program began in March of 2020 and has grown in popularity during the course of the pandemic. It is open to anyone over 18 that might enjoy some friendly communication. Begin a friendship via email or regular mail. Participants are paired with a person from a different generation. NEW TO THE PROGRAM: If you are under 55 please try and recruit an older adult to sign up with you. This can be a grandparent, parent, or a neighbor and does not have to be the person you will write with.

#### RN STUDENTS AND SENIORS LEARN FROM EACH OTHER

The University of Wisconsin Madison recruited five older adult volunteers from the Madison Senior Center this past fall for their virtual teaching of RN students. The program involves regular virtual meetings to discuss health topics and assessments. Students complete final written reports describing their

experience, what they learned, and how nurses can promote healthy aging. It is likely that this program will continue in the Spring Semester of 2021.

The Edgewood College RN program has been canceled for the Fall semester. However, in Spring of 2021 MSC and Edgewood College are looking to pair older adult volunteers with students for a series of discussions, zoom (computer) chats, or phone conversations. The topics will expand beyond medical topics to discussions about: nutrition, recreation, and coping with COVID. This program enhances general well-being, increases socialization, and provides an opportunity for a mental health check-in for BOTH the student and volunteer.

### PRESCHOOL CRAFT PROGRAM

We continue to work with local elementary school St. James on the PreSchool Craft program. Instead of in-person the older adults are meeting with their children online via zoom. Together they work on a craft project, participate in story time, and interact together. More dates for this are forthcoming so stay tuned and contact the senior center if you are interested.
