# CONSTRUCTION/DEMOLITION/REMODELING REPORT FORM

---

Per City Ordinance 10.185, certain construction and remodeling projects are required to recycle certain debris materials generated from the work. The ordinance also requires that all demolition projects recycle certain generated debris.

If your project meets one of the below standards, then the ordinance applies to your project. You may use the reverse side of this form to report the recycling totals.

The form should be submitted to the Recycling Coordinator within 60 days of the completion of the project. The completed form and supporting documents can be mailed to the Recycling Coordinator at 1501 W. Badger Rd., Madison, WI, 53713. You can also email the material totals from your project to [streets@cityofmadison.com](mailto:streets@cityofmadison.com). If available, you can attach scanned copies of the supporting documents to this email that verify the reported recycling totals.

### NEW CONSTRUCTION

- New construction projects that use concrete or steel supports must recycle 70% of their construction debris by weight.
- New construction projects that use wood framing must recycle the following materials:
  - » Clean wood
  - » Clean drywall
  - » Shingles
  - » Corrugated cardboard
  - » Metal

### REMODELING PROJECT

- Remodeling projects with a value in excess of \$20,000 must recycle the following materials:
  - » Clean wood
  - » Clean drywall
  - » Shingles
  - » Corrugated cardboard
  - » Metal

### DEMOLITION PROJECTS

Prior to receiving a demolition permit, persons must file a Reuse and Recycling Plan with the Recycling Coordinator. The Reuse and Recycling Plan must include the following information. Specifics on which vendors will be used to perform the below tasks are necessary for the plan to be approved:

- Reuse plan
  - » Habitat for Humanity and other organizations can reuse construction materials prior to their demolition
- Appliance recycling
- Mercury recovery/recycling
- Mixed loads of construction debris recycling
- Asphalt, brick, and concrete recycling
- Metal recycling
- Shingles recycling
- Clean wood recycling
